

Superintendent's Report

John asked that the people present tonight and the board join him in a moment of silence for the loss of a Jameson teacher, Jennifer Drapeau, she was 31 years old. She went out on leave in January. He wanted to talk about this week and all that has happened with Jen. Mrs. Fletcher, Mike Flaherty, Peter Flaherty and myself attended her funeral. Condolences go out to her husband Joey, and her two daughters Bryn and Aria. Barb was great in all she did this week in dealing with the tragedy, dealing with staff, dealing with the media and I am more proud of Barb Fletcher then my words are adequate. She handled the situation better than any principal could have. Cynthia Robbins made these beautiful pins with a grey ribbon and a wooden purple heart for staff to wear.

Moving away from that on to school business. Mr. Peter Flaherty, Mrs. Cox and I attended a workshop with Drummond and Woodsum about school consolidation. It was the same workshop I attended a month ago. There are some incentives, but not much for us since we are minimal receivers. My suggestion would be to wait it out and see what others bring to the table before making moves.

Test scores at our schools were up significantly from last year. John looked at similar demographics to compare our scores with theirs and we scored higher than a lot of them. Our scores are higher then they were last year. OOB High School is up 14 % in Science, 11% in Math and 12% in English. At LMS the scores went up 17% in Science and 4% higher in both Math and English. Because we are a small district and don't have a lot of kids, taking these tests in the schools, we are subject to more of an ebb and flow. If 5 kids do not do well on the testing it makes a big difference for us. We are going to change our practices so we can get more of our kids at that proficiency level where the state wants us.


