
## **RSU 23 Board Minutes**

## Superintendent's Report

Superintendent Suttie introduced Ben Harris, Jameson Elementary School Principal as well as Cynthia Potenza new HR Manager. We still have some openings in our district. All schools in Maine are struggling so it is not different then us. We currently have 5 special education ed tech openings and 1 regular education ed tech, 1 special education Teacher, 1 special education admin assistant, 1 food service attendant, 1 maintenance & facilities person and 2 custodians. Our current staff is going to cover our educational openings and our admins will fill in after that. We will have a company come in after the schools leave to help us with the two custodian openings. We are able to start school and still educate our children at the beginning of the year. Our track completion date has been moved to August 29th. We have some temporary irrigation systems up to help with the seeding that was put down after the track was completed. In speaking of the track and other maintenance and facilities issues we have had this year; I would like to give a huge shout out to Kevin Girard for spearheading the track project and who has been around all summer managing many projects. The superintendent would like to remind the public that even though lunch and breakfast are free we still need all families to fill out the free and reduced application. This drives how much funding we get from the DOE. It is imperative everyone fills them out even though meals are still free. The portal for returning enrolling students is open. There is a link in each principal memo for parents to enter the portal and complete the information. Shout out to the OOB summer rec staff in collaborations with our teachers to help deliver lessons to our students that missed some learning. Worked out perfectly. Appreciate the summer rec staff for doing that over the summer.

Buildings are all clean and we are in good shape to start school.
